#### IV. Executive Director Report

The Castellina Lottery winner was drawn just prior to the board meeting. The winner was very gracious to the Town of Mountain Village for providing affordable housing to local employees. An update on the status of the Telluride biennial compliance check was provided. The implementation of Kintone and Mailchimp allowed for mass mailing of the compliance paperwork and the ability to follow up immediately. As a result, there has been significant response. There were only three households whose hours were minimally impacted by the COVID pandemic.

#### V. Other Business

Lois Major reviewed the current policy in place for a violation of SMC covenants. At this time owners who are in violation have on year to remedy the violation and failure to do so would lead to a costly and drawn out lawsuit. Lois recommended the SMRHA Board consider a fine structure for covenant violations and make a recommendation to the BOCC. Amy Markwell reviewed what it would take to amend the covenants to include a fine structure for violations. She also noted that in order for current owners to be subject to a new violation policy, the owners would have to agree to sign the amended covenant. Otherwise, the amended covenant would be implemented as the units transferred to new owners. Suggested fine categories were discussed as well as the potential impact on those owners already struggling financially. To move forward, it was agreed that the Town of Telluride and Town of Mountain Village would share their current violation policy with the SMRHA Board for review at the February 2021 board meeting.
